

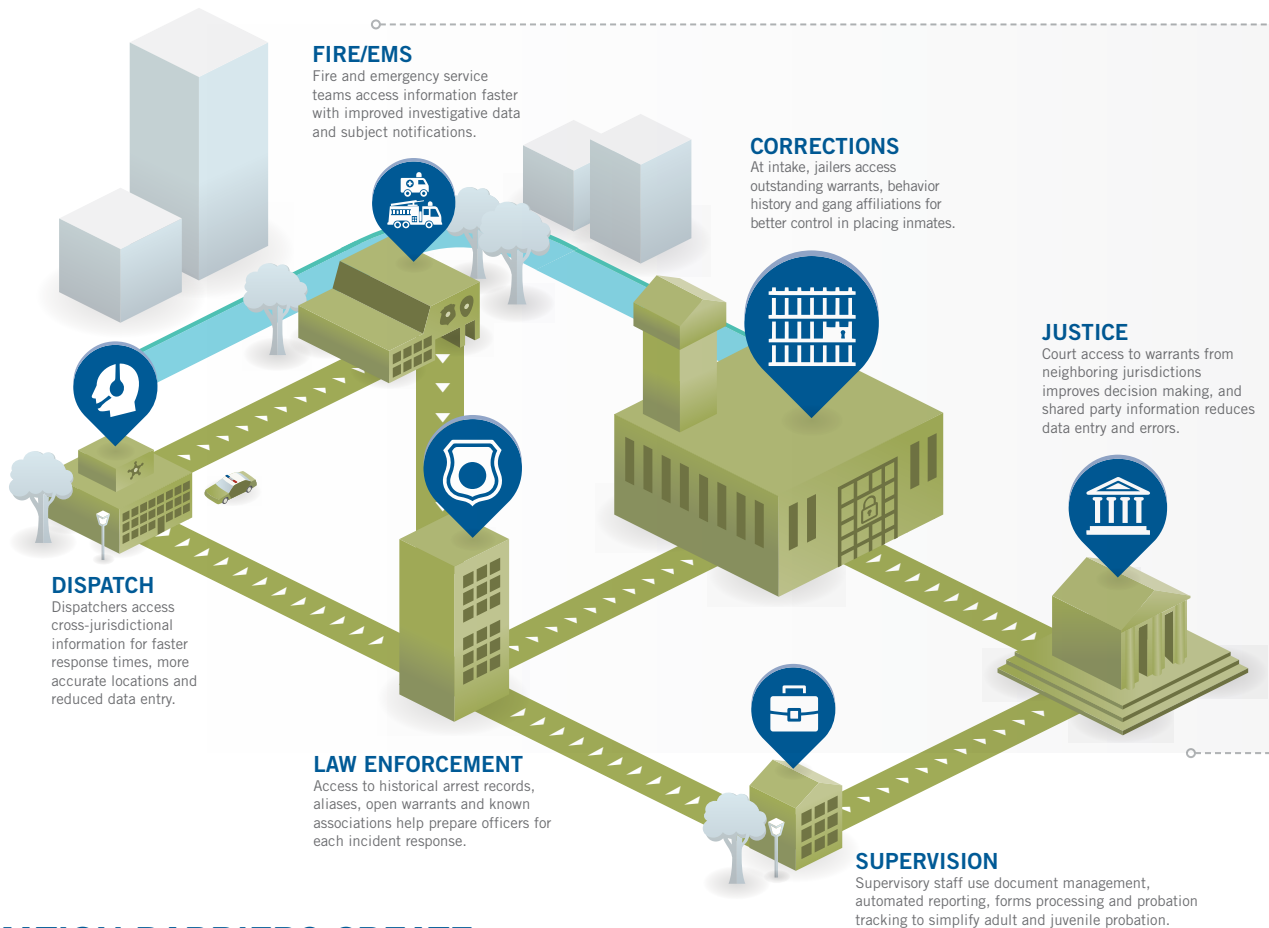

## INFORMATION BARRIERS CREATE INEFFICIENCIES IN PUBLIC SAFETY AND JUSTICE AGENCIES

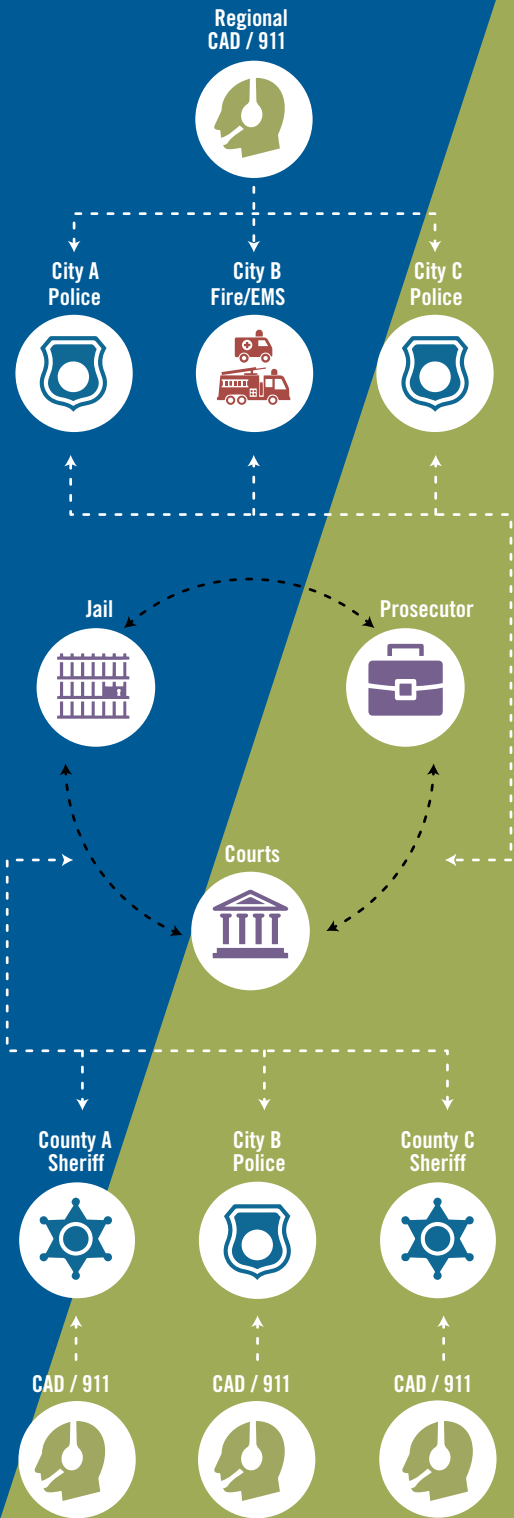

- **Saves time for prosecutors/attorneys:** Prosecutors and attorneys can make better decisions based on more detailed information — status updates, party data, hearing schedules, warrants and more.
